

MINUTES OF COUNCIL

A regular session of Troy City Council was held on Monday, May 15, 2023 at 7:00 p.m. in Council Chambers, City Hall.

INVOCATION & PLEDGE OF ALLEGIANCE: An invocation was given by Council Member Rozell, followed by the Pledge of Allegiance.

MINUTES: The Clerk gave a summary of the minutes of the May 1, 2023, meeting of Troy City Council. There were no corrections or additions to these minutes. Upon motion of Mr. Rozell, seconded by Mr. Pierce, these minutes were approved by unanimous roll call vote.

COMMITTEE REPORTS:

Buildings & Utilities Committee: Mrs. Marshall, Chairman, reported that Committee recommends legislation be prepared authorizing the Director of Public Service and Safety to enter into professional services agreements with Jones & Henry Engineers, Ltd. of Cincinnati, Ohio, for the following design projects:

- Chlorine Gas Conversion Project for the Water Treatment Plant at a cost not to exceed \$226,430
- Valve Replacement Project for the Water Treatment Plant at a cost not to exceed \$120,310

Community & Economic Development Committee: Mr. Schilling, Chairman, reported that Committee supports the recommendation of the Troy Planning Commission, and recommends that Ordinance No. O-21-2023 be adopted to rezone 15 S. Oxford Street from B-2, General Business District, to OR-1, Office Residence District.

Streets & Sidewalks Committee: Mr. Phillips, Chairman, reported as follows:

1. Committee recommends legislation be prepared authorizing the Director of Public Service and Safety to enter into an Easement Agreement with Busted Brick Realty Group, LLC related to an encroachment into the public Right-of-Way of North Cherry Street to permit the construction of an exterior stairway to the roof. So that the redevelopment of this building can continue without delay, Committee supports emergency legislation.

2. Committee recommends legislation be prepared authorizing the final assessment for Phase 14 of the Sidewalk Improvement Program. Committee member Snee will recuse herself from the recommendation as she is a property owner within Phase 14.
